
Please be advised that the Board of Recycle NB completed a comprehensive review of the proposed stewardship plan dated and submitted March 22, 2023, as well as having reviewed and considered the applicability of the Recycle NB Policy on Approving a Product Stewardship Plan.

As a result of our review of the stewardship plan and the associated policy, the Recycle NB Board has recorded in its meeting minutes the following decision: New Brunswick Stewardship Plan for Packaging and Paper dated March 22, 2023, and submitted to Recycle NB by Circular Materials Atlantic is **approved effective May 5, 2023**, and **will expire on December 31, 2026**. This decision will allow the launch of the first phase of the program to occur on or before November 1, 2023.

The Board of Recycle NB looks forward to a collaborative and cooperative partnership with Circular Materials Atlantic as the Packaging and Paper Products program is made available to the residents of the province.
